She understood that the baby she was carrying was a human with a heartbeat—the same human before and after birth. St. Gianna also recognized that her baby deserved to live, just like everyone else. Just as a baby needs its parents to provide life necessities such as food and shelter, so too does the mother's womb provide for the growing little human being.

This does not mean the value of the child's life is greater than the mother's. Every human has a unique story of growth, adventure, and potential. The beauty of life lies in its interconnectedness: parents sacrificing for children, children learning from parents, and the cycle of life continuing. Becoming a parent can be both a challenging and beautiful experience, and through raising their children, parents learn many virtues such as patience, empathy, resilience, and selflessness.
